I realize it is mandatory that I wear a helmet at all times while biking and that I obey all trail signs and remain on open trails.

I understand that I am financially responsible for the replacing/repairing of the bicycle and any of it's components if any damage occurs while in my use. I acknowledge that I will be charged the full retail value of any rental equipment that is not returned due to loss or theft.
